INTENT OF FY 2025/25 – 2029/30 CIP

- Support Core Goals of Good Governance and Fiscal Stability
- Take First Steps to Ensure Prudent Financial Management and Fully Funded Five-Year Capital Improvement Plan
- Build on Prior Work to Define Deferred Capital Improvement Programs for Town Facilities and Lifecycle Assets



INTENT OF FY 2025/25 – 2029/30 CIP

Effectively Manage Town Assets Including:

- Parks and Open Space: 17 Areas, 223 Acres, 9 Miles of Trail
- Roadways: 113 miles (236 lane miles), 31 Traffic Signals, 2,100 Streetlights, 576,000 Linear Feet of Sidewalk
- Public Buildings: 12 Buildings Totaling 139,373 Square Feet
- Parking Lots: 23 surface lots plus one underground parking structure
- Ancillary Assets: 5 Park Restrooms, Storm Drainage systems, Guard Rails, Retaining Walls, and Signage



CHANGES IN PROPOSED CIP

- \$4.9 million CIP
- Eliminates Measure G Transfer to CIP
- 14 Projects Completed / Consolidated / Withdrawn
- Remaining Projects Categorized by Tier

TIER 1 / TIER 2 / TIER 3

- Projects in Past CIP's Tier 1 or Tier 2 (Staff Report Attachment 1)
- Other Known Needs Tier 3 (Staff Report Attachment 2)
- Tier 1 In Progress, Grant Funded, Substantial Progress Expected in FY25/26
- Tier 2 All Remaining Projects in Prior CIP's
 - Divided into Four Classes Shown in Attachment 1
 - Will be Released for Work as Funding and Staff Time Permits
- Recognizes Staffing Levels are Limited and that Carryforward Funding has Been Excessive in Recent Years



PROJECT SPECIFIC CHANGES – TIER 1

- Storm Drainage Mapping Added Storm Drain Funds to Complete Work in Progress
- Vasona Oaks Drainage (NEW) New Project to Correct Failing Drainage System
- Shannon Road Repair Added All Funds from Retaining Wall Project to Support Anticipated Overages in Construction Bids
- Roadside and Open Space Vegetation Management Retained \$100,000 New Funding To Each



PROJECT SPECIFIC CHANGES – TIER 1

- Sport Court Resurfacing Repurposed Project to Focus Efforts at La Rinconada Court
- IT Disaster Resiliency (NEW) New Project To Support Town's Emergency Management Efforts; Funded from IT Fund
- Auto Gate Replacements at POB and PPW (NEW) New Project to Support Site Security
- EV Chargers at 41 Miles (NEW) Added Funds to Supplement Grant Accepted through Town Council Action on 3/4/25
