Thank you for your email. Your response states that privileged information has been received and provided to the Town Council. Thank you for clearing that up.

I am wondering however, why is it accurate to state "staff is gathering information regarding the methodology used and will schedule this topic for future discussion" if in fact a determination about the methodology has been reached which the Staff now believes the resolution should be suspended? The statement appears to be misleading by downplaying the significance of the privileged information and the decision to suspend. How often do resolutions get suspended based on subsequent information being received? I would think not very often.

Access to information concerning the conduct of the people's business is fundamental and necessary right of every person. I would encourage the Staff to fully disclose the information that has been received. It is difficult to understand why public disclosure is inappropriate.
