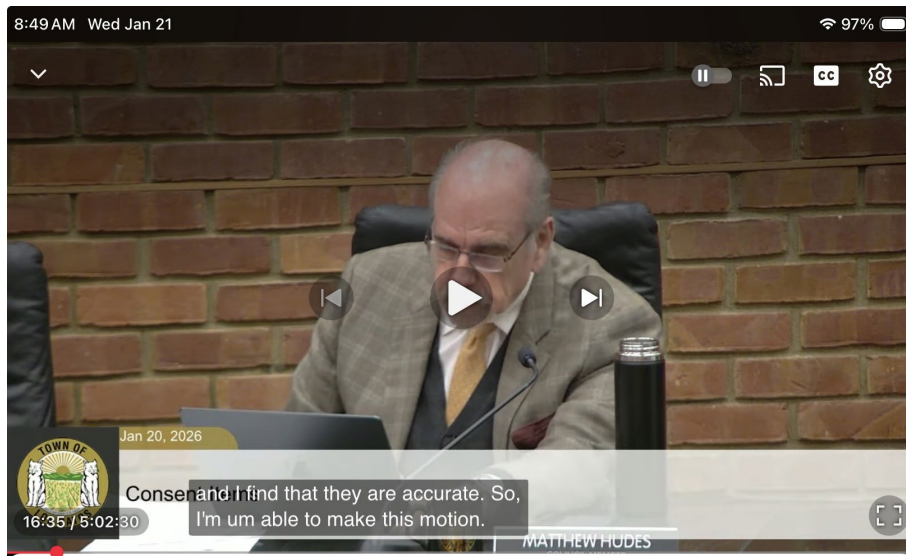
All fall on the Town Attorney- Town Manager.. Town Council..
